Basic Qualifications:

Experience: A minimum of five years experience relevant to the job description and working conditions below. Must have worked in three or more of the following: HVAC, Plumbing, Electrical, Mechanical, Carpentry, Masonry, or other Construction/Structural trades. Basic knowledge of quality control concepts required. Knowledge of fundamental math skills and practical measurement skills required. Understanding of technical data (service manuals, blueprints, etc) to determine inspection methods required. Experience in a variety of computer software applications to include; word processing, spreadsheets, and email software required. Operation of standard office equipment experience required. Must have excellent written and verbal communication skills. Work requires accurate data entry skills. Base Operating Services (BOS) contract experience a plus.

Education Requirements: High school diploma or equivalent.

Licenses and Certifications Requirements: Valid Florida driver's license or equivalent required.

Job Description:

- Implements quality control programs that achieve project-level objectives and contractual obligations.
- Interfaces with the Contracting Officer, and Contracting Officer's Representative's, responsible for evaluating contract performance.
- Assists with the preparation, editing, and issuance of revisions to the Quality Control Plan (QCP).
- Ensures that scheduled/random inspections are conducted and deficiencies reported.
- Assists in monitoring FFS and subcontractor personnel to ascertain that changes in procedures and methods required to improve performance are implemented and working effectively.
- Conducts audits, surveys, studies, spot-checks, and follow-up inspections of functions, work processes, equipment, facilities, and records.
- Documents discrepancies discovered during inspections and submits formal correspondence to the appropriate supervisory personnel for corrective action via Performance Deficiency Reports.
- Assists with QCP training/cross training of leads, supervisors, and management personnel.
- Helps to enforce effective and timely corrective actions with minimum recurrence of problems.

- Conducts investigations of customer complaints, implement corrective actions required, follow-up to determine effectiveness of action, and assist with documentation and submittal to the COR in accordance with Navy regulations.
- Participates in fact-finding groups to investigate quality levels and cause(s) of defects and/ or performs analysis.
- Uses technical data (service manuals, blueprints, etc) to determine inspection methods.
- Utilizes Material Safety Data Sheets to identify chemical characteristics.
- Completes time sheets daily and accurately.
- Work also involves other duties as assigned, including compliance with the provisions of the Employee Handbook.

Physical Effort: Inspector's often lift, carry, and handle tools and equipment required to perform inspections. They occasionally work in cramped and inconvenient surroundings requiring manipulation of equipment in awkward positions for prolonged periods. Work frequently requires standing, stooping, bending, kneeling, climbing, and working in tiring, awkward and uncomfortable positions for brief periods. Must be able to ascend and descend on ladders both engaged and open of various heights up to and including 35 feet. Perform visual inspection from ladders, scaffolding or platforms where components of systems under inspection are frequently in hard-to-reach locations.

Working Conditions: The work is accomplished both indoors and outdoors, all climates, including working outside and on top of tall buildings, often exposed to hot sun or cold weather climates for extended periods of time. Frequently works in cramped spaces, hot/cold attic spaces, areas with low overheads requiring stooped or crouched maneuvering, and areas with hot/cold, oily, wet, and dusty surfaces. Inspectors are frequently subject to sudden temperature changes when inspecting refrigerated equipment such as walk-in coolers and freezers. The Inspector is exposed to moving parts and equipment, or machinery while working in and around HVAC units and compressors, exhaust fan assemblies, etc. May be called in for off-hours emergency situations including weekends and holidays. Limited work required in asbestos containing areas, with company training and protective equipment provided.
